eldest brother, Mohammed Sabir, remains as Chairman of the Aagrah Group; the middle one Zafar Iqbal - Vice Chairman of the Aagrah Group; the middle one, Zafar Iqbal - Vice Chairman; and the youngest, Mohammed Aslam serves as the Groups' Managing Director.

Aslam explains: "We had separate food preparation areas and kitchens in each of the different branches."

in each of the different branches and after a while this became unfeasible. We wanted to create a sense of consistency and so we developed a 'central kitchen' in the Pudsey branch where everything prepared before delivered to the other branches in specially developed sealed refrigerated vans.

"Although the Board thought I was crazy at first for suggesting this, they soon realised it was the obvious way of running things most efficiently."

Aslam believes the success of the Aagrah Group can be traced back to the very early days of the company when he and his brothers

started something different.

He explains: "At that time, we were doing something pretty unusual for the average curry house.

"We were using all fresh ingredients; we were blending our spices and had totally moved away from buying in this red sauce and this green sauce and mixing them in with a few dried onions. I'm exaggerating of course, but the point I'm making is that the vast majority of curry houses at the time were still

producing a hybrid curry for the English palate, and very few were

using all fresh ingredients."

It was this commitment to high quality food that has won the company numerous accolades.

Not only that, over the years they've catered for national snooker tournaments, created curry sauces, spice blends and other products to be sold at supermarkets, held chef masterclasses as well as feeding

celebrities from across the globe. In 2007, Aagrah were the official food partners for the IIFAs (International Indian Academy awards) Bollywood royalty where such Amitabh Bachchan, Dharmedra, Shilpa Shetty and Aishwarya Rai-Bachchan to mention a few, attended the week-long entertainment events in Yorkshire.

So, what does Aslam believe the future holds for the business?

He concludes: "My brothers and I have built the business up to where it is today. I'm extremely proud of what we've done and how we've shared our passion for promoting Asian cuisine.

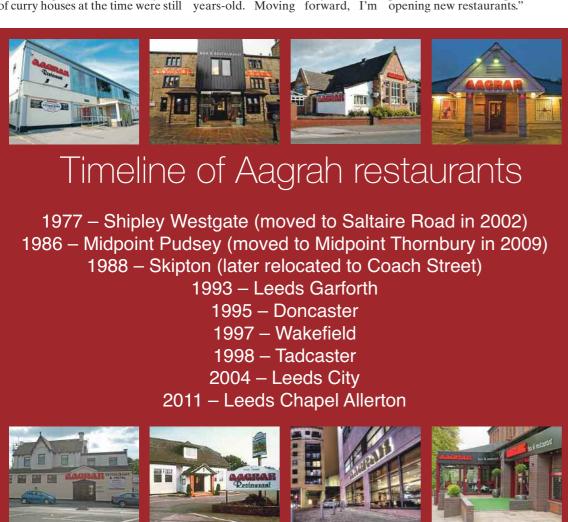
"Looking ahead to the future it's now all about handing over to the next generation – our sons and nephews – to continue driving the business forward. They're not new to the business.

"We're a family orientated business and many of them have been involved since they were 16years-old. Moving forward, I'm

In this deeply-researched book,
Mann uses rare anecdotes to provide
recognition of early descriptions from
administrators, writers and illustrators
who depicted the history of the Sikhs
and the land of the Punjab.

Sikh Military History is sometimes only seen through the lens of World War I and II. Yet the tradition was an inbuilt system from the faith's inception in the 15th Century.

Standing up to tyranny and oppression whilst espousing values of peace and freedom of others was paramount. Whilst facing tremendous odds under the conquest of the Mughals and the Afghans, Sikhs rose to create a band of warriors known as the Misls in the 18th Century.

This would lead to the golden age of the Sikh Empire (1799-1849) formulated by Maharajah Ranjit Singh.

The empire was a world power and

had diplomatic links with the British and the French as well as governments within South Asia.

However the Anglo Sikh Wars saw the Sikh Empire come into conflict with the East India Company, which eventually led to the annexation of the Punjab.

The Sikhs were absorbed into the

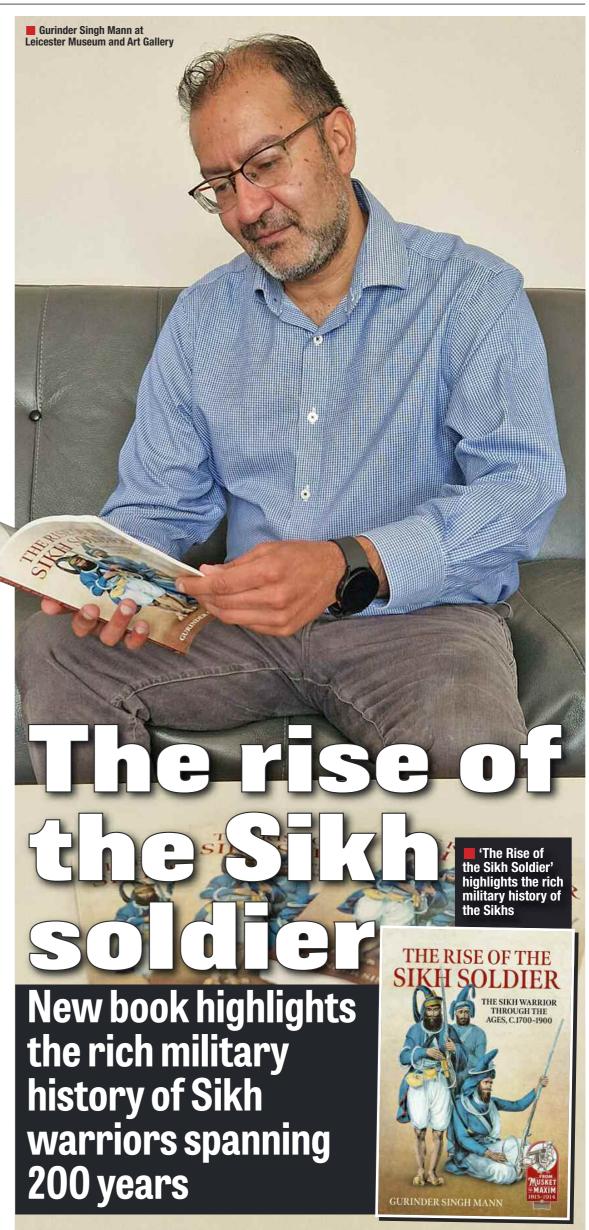
The Sikhs were absorbed into the British India Army, leading to them to participate in many military campaigns across the world. This included arenas in Africa, Europe as well as South Asia. This paved the way to Sikh recruitment during the World Wars.

The book also gives credence to the underrepresented role of women warriors and how they were pivotal to many campaigns.

Mann has undertaken research for the book by visiting India, including visiting the battlefields of the Anglo Sikh Wars and unearthing rare photographs from public and private collections in the UK. The book is supplemented with maps of battles, rare military images, relics and artefacts, together with the appendices citing important documents and letters.

Commenting on the book, Gurinder Singh Mann, said: "This book serves as a commentary of Sikh Military history over 200 years. It covers the important people and events which shaped the Sikhs into an Empire through to the Colonial period. It will appeal to people who want a wider understanding on how the Sikhs developed through translations, correspondence and military warfare and to anyone wishing to learn more about Sikh valour and chivalry."

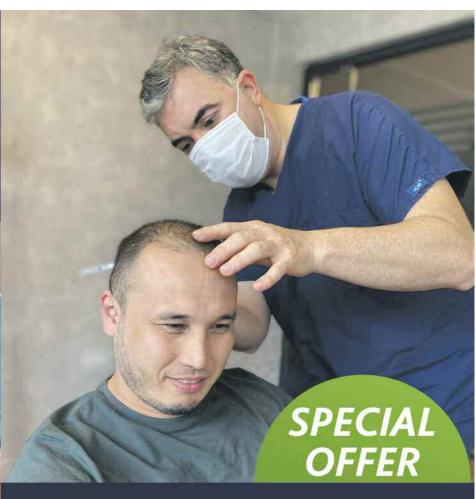

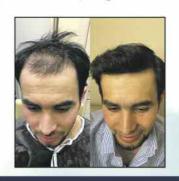

Amir Khan: Three men arrested after boxer's £70,000 watch was stolen at gunpoi

Three men have been arrested that offence and possession of taken off me at gun point in East ammunition. All three are in London, Leyton. I crossed the road after boxer Amir Khan had his £70,000 Franck Muller watch stolen at gunpoint in London earlier this

The former world champion, 35, and his wife Faryal were threatened by two men in Leyton, at 9.15pm on 18th April.

The three suspects, aged 20, 25 and 34, were arrested on suspicion of robbery after warrants were carried out, Scotland Yard said.

The 25-year-old man has also been arrested on suspicion of possession of a firearm with intent to cause fear of violence, while the 20-year-old has been arrested for

At the time of the incident, custom-made, one-off Khan's Franck Muller timepiece was described by police as 'easily' recognisable.

"If you, or anyone you know is offered the watch at a discounted price please contact us immediately," Detective Constable Ben Grix said.

Khan, the former WBA and IBF light-welterweight champion, said he and Faryal were 'both safe' following the incident.

He tweeted: "Just had my watch

with Faryal - luckily she was few steps behind me.

Two men ran to me, he asked for my watch whilst having a gun pointed in my face.

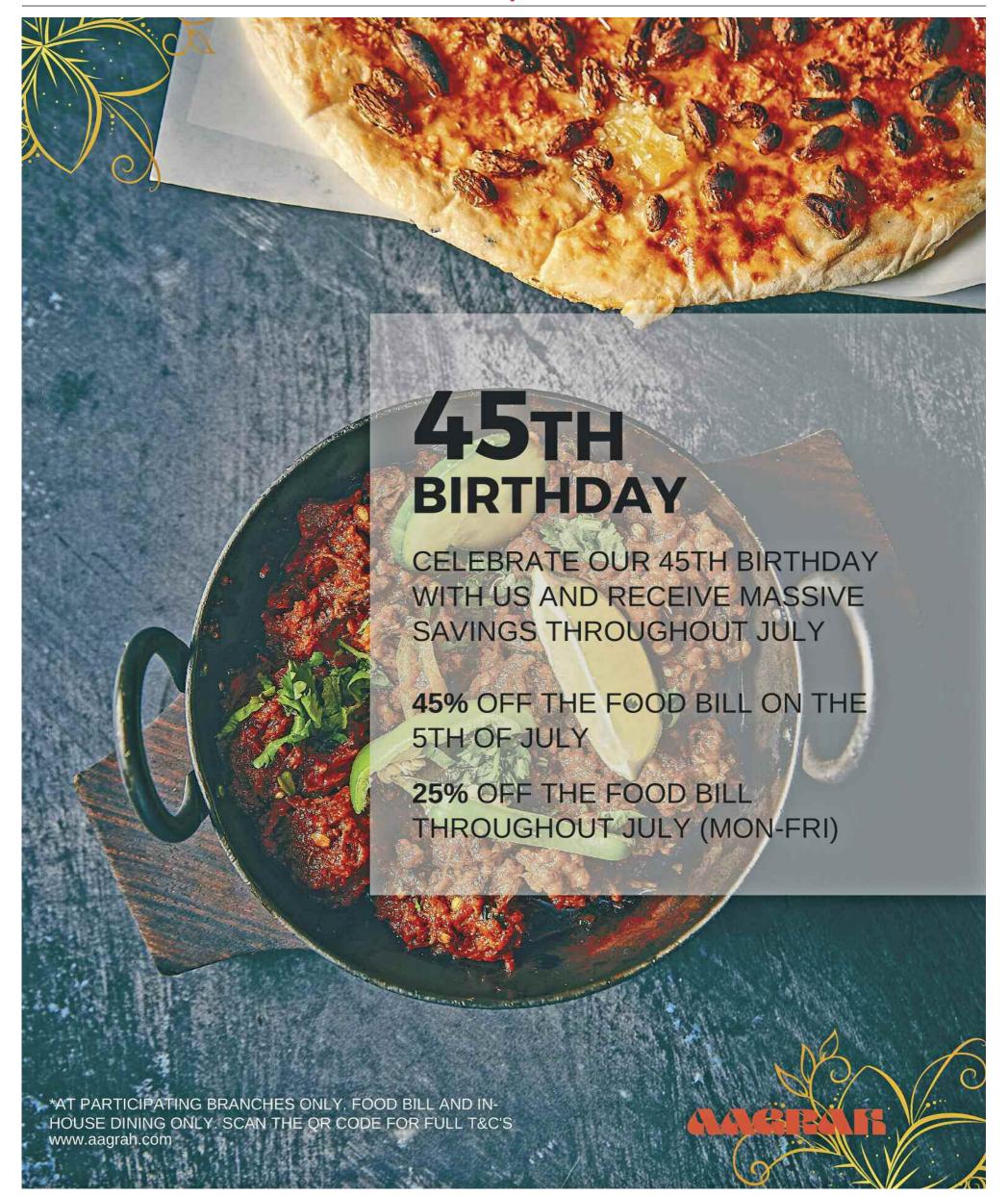

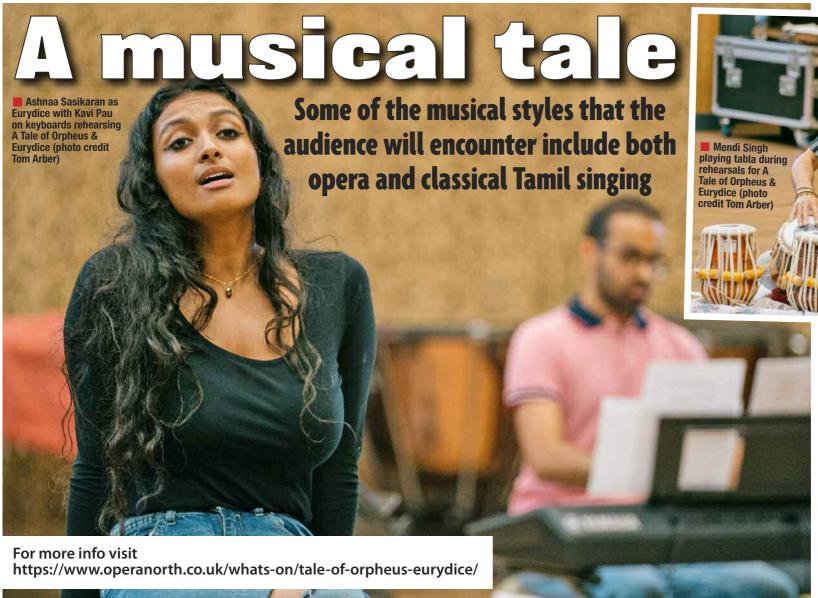

Opera North explores a wealth of musical styles from South Asian classical, opera and folk to jazz, blues and soul

A new show which celebrates music from around the world through the timeless story of Orpheus and Eurydice will be touring the north of England this month as Opera North takes its latest pop-up production on the

Inspired by Monteverdi's opera Orfeo, A Tale of Orpheus & Eurydice transforms the myth of the two star-crossed lovers into a modern-day fable.

Audiences will be taken on a 45minute musical odyssey as the two characters reminisce about their first meeting and how they negotiated their way through an unfamiliar city. On the way, they explore a wealth of musical styles from South Asian classical, opera and folk to jazz, blues and soul, including a new song composed by sitarist, composer and Opera North's artist-in-residence Jasdeep Singh Degun.

The joyful celebration of music and love is a collaboration between Opera North and South Asian Arts-uk (SAA-uk) and features performers from both South Asian and Western musical traditions.

Operatic tenor Nicholas Watts

brings Orpheus to life alongside British-Tamil Carnatic singer Ashnaa Sasikaran as Eurydice. Both will assume the same roles when Orpheus, Opera North and SAAnew reimagining Monteverdi's opera Orfeo, opens at the Leeds Grand Theatre in

Providing musical accompaniment for the show is British Indian composer and keyboardist Kavi Pau. He is joined by tabla player Mendi Singh who was one of the participants in the latest Opera North Resonance residencies offering creative opportunities to musicians of colour. mone Ibbett-Brown directs with Hannah Sibai providing set and costume design.

As director Simone Ibbett-Brown says: "This show provides an amazing introduction to the two artists who will be appearing in Orpheus in the autumn and to some the musical styles that the audience will encounter, including both opera and classical Tamil

singing.

"Reflecting what will happen in accordance we've the main-stage production, we've also been able to write Eurydice back into the action, building on the scant few lines she was given in Monteverdi's original work. Trainee police officer faked Covid test

Ahmed Anwari drew red lines on lateral flow test in bid to stay home from work

A trainee police officer tried to fake having COVID-19 by drawing red lines on a lateral flow test, a tribunal has heard.

In a bid to stay home from work, Ahmed Anwari told his training officer last December that he could not come in because of a positive lateral flow test result.

But his ruse was uncovered when he was asked to send a photograph of the result as proof and it became "clear that the test had been manually altered with drawn red lines", his disciplinary was told.

The Lancashire Constabulary officer was then invited to take a coronavirus test on a Microsoft Teams meeting in which he again falsely claimed the result was positive.

When confronted, Mr Anwari admitted faking the test and lying, saying he did it so he could stay at home under the then self-isolation rules.

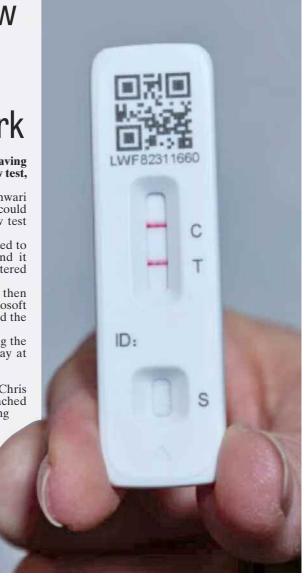
He resigned from the force a day later.

Chairing the hearing, Chief Constable Chris Rowley found that Mr Anwari had breached standards of professional behaviour and in doing so had committed gross misconduct.

so had committed gross misconduct.

He said: "I find that had Mr Anwari still been a member of Lancashire Constabulary he would have been dismissed.

"Police officers must keep in mind at all times that the public expect them to maintain high standards of professional behaviour."

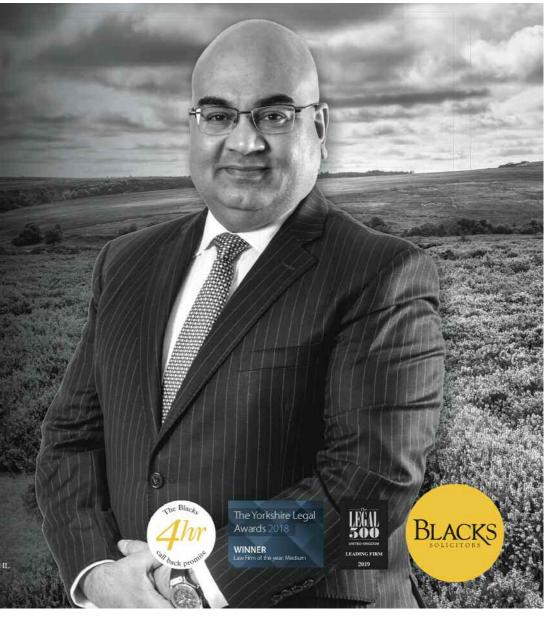

Diabetes UK are calling on NHS systems across the North of England to put diabetes at the heart of local health plans so people living with, and at risk of, diabetes get the care they need as the numbers of people living

with the condition continues to rise.

The announcement, comes after the charity recently revealed that thousands of people with diabetes are still struggling to access vital care. Those from the most deprived areas of the country are least libely to have of the country are least likely to have

access to the care they need.

In the North of England, there are

Diabetes UK calls for action as now over 1 million people diagnosed with diabetes while just 34 per cent of people diagnosed with the condition in the region have received all eight of the recommended care checks in 2020/21.

A recent survey from the charity also showed that 48 per cent of people in the North East & Yorkshire

said they had difficulties managing their condition during 2021.

People living in the most deprived areas of the region were more likely to have had difficulty with 56% in the most deprived compared to 43% in the least deprived and of those who experienced difficulties managing their diabetes. 67% in North East & Yorkshire attributed this in part to

not having sufficient access to their healthcare team.

Clare Howarth, Head of the North of England at Diabetes UK said: "Diabetes can't wait. Without access to essential care people with diabetes risk serious complications, such as amputation, stroke, heart disease, sight loss and mental health

problems.
"These complications devastate lives and can even lead to early death, yet we know these are all avoidable if people receive the care and support they need and deserve."

Primark begins new online click-andcollect tria

resisting selling its clothes online, and will begin internet shopping through a new click-and-collect service for children's products.

The High Street retailer said 2,000 goods will be offered through a trial which will run out of 25

shops in the north west of England. Until now, Primark, which was founded in 1969, has resisted selling its products online unlike other retailers, and was particularly hard hit by Covid lockdown when businesses were closed. Rival companies, however flourished.

Parent company Associated British Foods (ABF) said the group has recently revamped its UK site to give more details of in-store ranges, so customers can browse the full collection and check availability before coming into

ABF said its new website, which launched in April, saw online traffic rise by around 60%, and that the to lockdown restrictions.

Primark has decided to give in to pandemic had accelerated the online changes that had been in the

pipeline prior to Covid.

It said the trial will allow customers who live nearer a smaller Primark store access to a much wider range of items.

"Our average-size stores are only

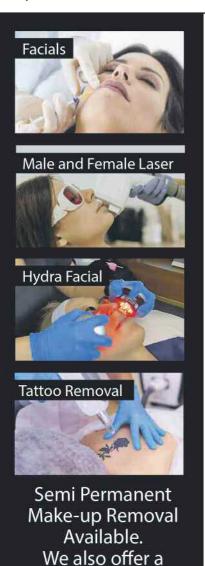
able to stock a limited range and for these customers the number of options available to them will broadly double, increasing even more for customers of our small stores," said ABF.

"This trial will enable us to provide more fashion, licence and lifestyle products to more customers and more often.

The group said Primark sales increased by 81% in the three months to the end of May,

Heavy monsoon rains over the past few days have led to rivers bursting their banks, cutting off around two million people in northeast Bangladesh. Many

families are stranded and could run

out of food within days.

Communities in low-lying areas in Sylhet and Sunamganj have been deluged. Homes and schools as well as vital infrastructure such as power supply lines, water sources and roads are all damaged or underwater. Many people have been affected by floods for the second time within weeks, after severe flooding also struck the region in mid-May.

The government of Bangladesh

The government of Bangladesh has deployed the army to evacuate people from affected areas, a mission made all the more urgent by predictions of worse flooding to come. In Sylhet, exams have been called off as schools are turned into temporary shelters for families fleeing their flooded homes.

Islamic Relief, which has been

working in the flood-prone country for over 30 years, is responding to this latest disaster by distributing life-saving aid over the coming days. As well as hiring boats to reach stranded people, we will be distributing food, water purification and hygiene items.

Shabel Firuz, Islamic Relief's Head of Asia region, says: "Many people are out of food and others will run out in the coming days. As markets are flooded and not operating, people have nowhere to buy supplies, so it's urgent that aid gets through to them.

"People's houses have been damaged, washed away or completely covered in the flood water. Thousands of people are looking to make their way to flood shelters where they will need a lot of support. Islamic Relief's office in Sylhet and the homes of some our staff have also been flooded."

Many families in the area depend on agriculture and livestock for food and income, and with precious paddy fields and pasture now underwater we are also planning to provide cash grants so that people can buy seeds, tools, fodder for animals and repair their shelters.

Islamic Relief will also be working closely with the ward disaster management committees set up through our extensive disaster-preparedness programming in Bangladesh. Made up of community volunteers, these local committees are among the first responders to crises such as these.

responders to crises such as these. Tufail Hussain, Director of Islamic Relief UK said: "Time is now running out for survivors of the worst floods to hit Bangladesh in 18 years, as food could run out in days. There are also fears of more floods to come which would be catastrophic for those already homeless and stranded.

New legislation to regulate UK smart charge points

New legislation is being introduced to regulate UK smart charge points and cables for electric cars.

This comes after the growing popularity of private electric car ownership, replacing diesel and petrol car models faster than previously anticipated.

The UK Government will oversee the implementation of new legislation designed to regulate and encourage how and when EV energy consumers use smart EV charging points at home and at work.

The increase in private ownership of electric cars has been precipitated by the Paris Agreement after COP 21. Expedited in 2022 after COP 26, where net-zero emission targets were locked into be reached by 2050. And with grants available for the adoption of electric vehicles over petrol or diesel vehicles, more people than ever before are choosing to make the switch.

As a direct result of these factors, new legislation has been drafted for enforcement in June 2022 to ensure that the national grid can keep up with the soaring demand for electricity from the surge in electric vehicle ownership.

The new legislation aims to introduce regulation that provides a more flexible and streamlined range of energy systems across the nation. These regulations are for private charge points that are sold for use in workplace or home environments.

It is the intention that by implementing these changes for private charging points, that the national grid will be able to supply appropriate amounts of electricity

to those who need it. It is also the intention of this legislation to ensure the national grid remains stable.

The regulations that are being introduced are designed to standarise device-level requirements of new smart charging points and cables sold after enforcement of the legislation has begun.

The purpose of smart functionality of charging points is to encourage charging when there's less demand on the national grid or when more renewable energy is available.

For users of electric vehicles, this means that new smart charging equipment purchased after the enforcement date will incorporate randomised delay function and pre-set, off peak charging hours by default. All this will be pre-programmed into the smart chargers themselves during the manufacturing process.

Default pre-set, off peak charging times can be removed and or changed during or after initial setup to suit your schedule.

The randomised delay function is designed to regulate how many EVs are charging from the national grid at any one given time. This is to prevent too many people charging their electric vehicles at the same time and putting stress on the national grid during peak times.

These regulations will be rolled out and enforced across the nation on 30th June 2022. Many companies that deal in electric car parts and accessories are already prepared for these changes with compliant charger models.

Stalker who terrorised

threats jailed

He identified his victims online and even paid for online services such as ancestry records in order to obtain their names and full address details



A man who stalked and terrorised 121 victims online by posting graphic threats of sexual violence along with their details has been jailed. Vishaal Vijapura, 28, of Shirley,

Croydon, was sentenced at Croydon Crown Court to two years and eight months' imprisonment. He also received a Sexual Harm Prevention Order for a term of five years.
Vijapura identified the victims

online and then followed this up by paying for online services such as ancestry records in order to obtain their names and full address details.

He then published online containing the victim's personal details, as well as a short essay attempting to justify raping the women, more victims came to light the intense during

investigation.

On many other occasions, Vijapura took the victims images from their personal social media profiles and published these with a rhetoric stating that the victims outlandish gratification, he also published posts online of them with their personal details encouraging serious sexual violence against them.

Vijapura sent many of the victims direct messages containing vile and horrific topics with sexualised themes throughout.

In some instances he paid an ancestry website in order to obtain

even more detailed personal information relating to the victims

and their families. Since receiving the allegations, detectives carried out a complex investigation involving the forensic analysis of many devices in order the gain the necessary

evidence to place Vijapura before the courts.

Detective Inspector Paul Smith, from the South Area Public Protection Unit, said: "The dedication and commitment from the officers working on the case, with national support from colleagues across the UK, has meant that Vijapura can no longer put these victims at fear of violence. Some of the victims police have contacted were too scared to venture out alone after the threats

received from Vijapura.
"The internet is now a safer place with future proofing against ongoing offending from this man in the form of a custodial sentence. This kind of criminality is dangerous and offensive and will absolutely not be tolerated.

"The victims in the case have shown great strength in coming forward. They have supported the investigation and provided evidence of how Vijapura's misogynistic behaviour has deeply affected their lives. It is wholly right that he has received a custodial sentence.

Housing market shows signs of cooling down

The housing market is showing signs of cooling, according to Halifax data, but the annual growth rate slowed in a sign that the cost of living crisis is cooling the market.

Mortgage lender Halifax said that while house prices continued to climb despite cost of living pressures and rising food and energy bills because demand for homes continued to outstrip supply.

House prices increased by 1% between April and May, or £2,857, taking the average price of a home to a record of £289,099.

While annual house price growth remains at the elevated level of 10.5%, this is the slowest rate of growth seen since the start of the year.

The rise meant the average price of a house hit another record of £289,099. This means prices have now climbed for eleven consecutive months.

However, mortgage activity

has started to slow, according to Halifax - part of Lloyds Banking Group, the country's biggest mortgage lender. This means it's expected that we will see a reduction in housing market activity.

Recent property price inflation has been felt differently by house hunters, depending on the type of home they were looking to

buy. Russell Galley, managing director at Halifax said: "Despite the very real cost of living pressures some people are experiencing, the imbalance between supply and demand for properties remains the primary reason driving the continued climb in house

"Compared with May last year, you'd need about £10,000 more to buy a flat, but an additional £50,000 for a detached home. This clearly creates a knock-on effect for

those looking to make their first home move, as the rungs on the housing ladder have become increasingly wider," he

"However, the housing market has begun to show

signs of cooling.
"Mortgage activity has started to come down and, coupled with the inflationary pressures currently exerted on household budgets, it's likely activity will start to slow," he added.

"So, there is perhaps one green shoot for prospective purchasers; with overall buying demand down compared to last year, we may be past the peak sellers' market."

Inflation - the rate at which

prices rise - hit 9% in April, a 40-year-high. The Bank of England has warned inflation might reach 10% within months, as the prices of fuel and food put pressure on household budgets.

Microscopic parasitic mites that live in the pores of the skin on our faces which may be destined for an evolutionary dead-end, according to new scientific analysis of their DNA.

More than 90% of us host the 0.3mm long-mites, known Demodex follicularum, in the oily folds on our faces, most living in the pores near our noses and eyelashes.

The mite spends its entire lifetime living in our skin follicles, and it's probably the closest relationship to another animal humans will ever

During the day they feed on our oily skin secretions, at night they leave the pore to find mates, and find new follicles in which to reproduce and lay their eggs.

If the thought makes you want to wash your face, forget it. You've been carrying the mites since you were born - they're passed from mother to baby during breast feeding - and live too deep in the pores to be washed out. And besides, we need them, says
Dr Alejandra Perotti of the
University of Reading, who coauthored the study.

We should love them because they're the only animals that live on our bodies our entire life and we should appreciate them because they clean our pores.

"Besides, they're cute," says Dr Perotti.

Perhaps not everyone would agree. The mites have four pairs of stubby legs each with a pair of claws. Beyond that a long worm like body which, under the microscope, can sometimes

be seen protruding from our hair follicles.

But this latest study, published in the journal Molecular Biology and Evolution, has shown just how incredibly intimate their relationship with humans has become.

The researchers analysed the genome of the mites and found it has the smallest number of functional genes of any arthropod (insects, arachnids and crustaceans).

The animals have become so

dependent on their human host that their genome is "eroding" - stripped down to the bare minimum of genes needed to survive, the researchers conclude.

They found that the gene which normally regulates waking and sleeping in arthropods has been lost. Instead, the organism detects changes in levels of the hormone melatonin in our skin secretions. When we go to sleep levels go up - a signal to the Demodex to get up. When we wake up, hormone levels decrease - so their cue to head back down our oily pores for dinner.

They've also lost the gene that protects their bodies from UV light - what's the point

when you only out at come night? Even body plan is

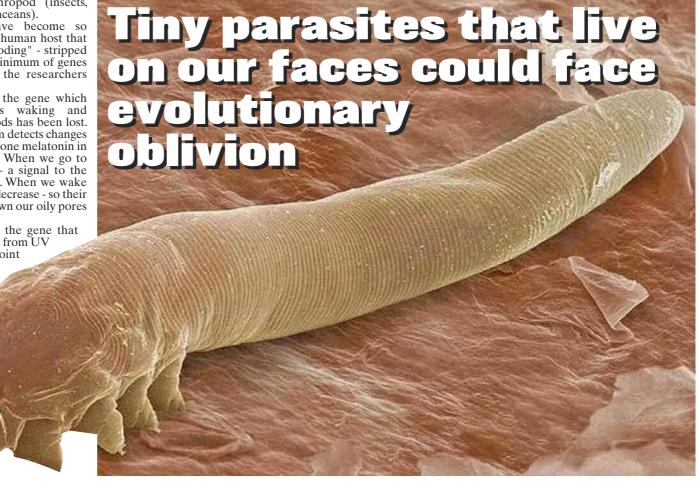

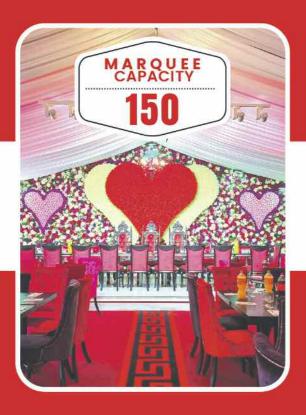

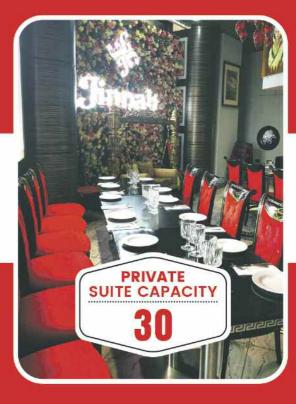

As baggage chaos hits airports, new research reveals the most commonly lost items at UK's busiest airport.

More than 170 iPhones have been lost at Heathrow alone over the past year, as the airport's luggage struggles are causing flight cancellations. Jackets, wallets, Kindles and bank cards also among most commonly mislaid things.

The study by financial comparison site Forbes Advisor has revealed that iPhones are the most commonly lost item at Heathrow, with 179 of the Apple smartphones being handed in at the airport's lost property office between the start of July 2021 and the end of May 2022 - equivalent to an iPhone being lost every two days.

The study, which analysed more than 5,000 items lost over the 11 month period, found that other Apple products are similarly lose-able, with 164 pairs of Airpods being mislaid at Heathrow, along with 24 Macbooks and a further 138 iPads. However the most commonly lost tablet is Amazon's Kindle, 146 of which were listed as missing.

A jacket is the second most commonly mislaid item at Heathrow 176 have been misplaced since July last year. A total of 171 lost wallets put the item in third place in the Heathrow loss rankings, while in fourth, 167 rings have slipped off fingers and been handed into lost property.

Lots of travellers are also failing to keep an eye out for their spectacles, with 165 pairs of reading glasses going missing, plus 106 pairs of sunglasses, while a total of 125 bank cards have been lost, as well as 84

passports. When When looking at broader categories of lost items, the most commonly lost were defined as "travel effects", of which 542 were mislaid in total, which includes things

like rucksacks, suitcases handbags.

In total 519 items of clothing were lost, while 493 security / identity documents were handed into the lost and found.

Commenting on the study, a spokesperson for Forbes Advisor said: "The stress of travelling means that it can be easy to misplace items, even those as essential as a smartphone. And this summer is shaping up to be even more stressful

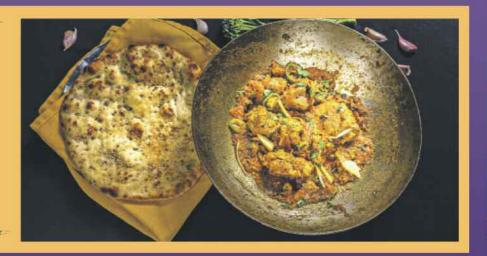

Is That Everything Sir?

ost commercial contracts will include a clause known as an "entire agreement clause". This type of clause is used to signify the intent of the parties that the written terms of the contract should represent the agreement between the parties in its entirety and that it will supersede all preceding agreements, negotiations or discussions that have not been set out in the agreement.

in the agreement.

The primary purpose of such a clause is to prevent the parties to a written agreement claiming that statements made before or during contract negotiations, which are not included in the final agreement, constitute either additional terms of the agreement or a form of side or collateral agreement.

Entire Agreement Clauses provide commercial certainty for the parties to an agreement as the full extent of the agreement between them is contained in one single document. They also prevent potential litigation between the parties, which would not only be costly but also very time consuming, as they

force the parties to acknowledge that they are not relying on any statements or representations made before or during the contractual negotiations other than those expressly set out in the document and therefore they are effectively waiving their

rights to rely subsequently on anything said before the legal formation of the contract.

Entire Agreement Clauses must be reasonable under the Unfair Contract Terms Act 1977. If the parties are both commercial entities and the contract is made in a commercial context, it is unlikely that an Entire Agreement Clause excluding liability for precontract representations would be considered unreasonable. However, an Entire Agreement Clause cannot be used to exclude liability for fraudulent pre-contractual representations.

A typical Entire Agreement Clause will state that:

• The contract is the whole agreement between the parties.

• contract supersedes any previous agreements or understandings.

• The parties do not rely on any representation made prior to the making of the contract.

Although the Courts will uphold
Entire Agreement Clauses which are
expressed in general terms, the parties
should be aware of the limits to these
clauses and consider whether to provide
for express exclusions. If the parties
wish to exclude certain liabilities or to
ensure that a specific term is not
implied into a contract then this should
be expressly and clearly stated and they
should not assume that the Entire
Agreement Clause will cover the
position.

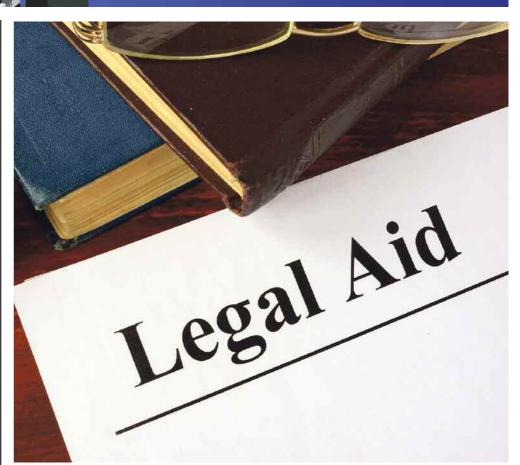

Legal aid supplier droughts will erode eligibility gains

The UK government must shore up the beleaguered legal aid market if more generous eligibility criteria are to benefit people on lower incomes, solicitors' leaders have warned.

The Law Society of England and Wales has published updated legal aid deserts maps to accompany its response to the Ministry of Justice consultation on changes to the legal aid means test.

"Legal aid is a lifeline for people, usually living in poverty, to help them in moments of crisis such as when they are facing eviction or seeking protection from a violent partner for themselves and their children," Law Society president I. Stephanie Boyce said.

Month after month law firms providing legal aid are closing their doors, leaving large areas of the country with no access to face-to-face legal aid services.

"The legal aid means test has not been updated in line with inflation for 13 years, in which time prices have risen 40%.

"The widening of eligibility that should now come from the government's proposals is good news, if long overdue.

"However, government wants to uprate the means test to 2019 prices, which is already out of date, and then freeze it at that level until 2026.

"By then the cost-of-living crisis is expected to have driven prices up by a breath-taking 20%, leaving many unable to afford legal advice but being judged by 2019 standards to be too wealthy to qualify for legal aid.

"People will also only see the benefits of eligibility changes if there is significant investment in the legal aid sector.

"Fewer and fewer firms can afford to provide civil legal aid advice because rates of pay for this work have not been uprated for 25 years.

"Our updated legal aid deserts maps show a sector in crisis. Month after month

law firms providing legal aid are closing their doors, leaving large areas of the country with no access to face-to-face legal aid services. "If the government truly

"If the government truly wants to ensure people facing poverty are not left to fend for themselves when they face life-changing legal problems, it must take a 360-degree approach:

"Uprate the means test annually to keep pace with the spiralling cost of living.

"Set thresholds so nobody's income and capital falls below a minimum standard of living if they have to pay their own legal costs.

"Invest in both criminal and civil legal aid providers so anyone eligible for legal aid can find an expert to help them when they need them."

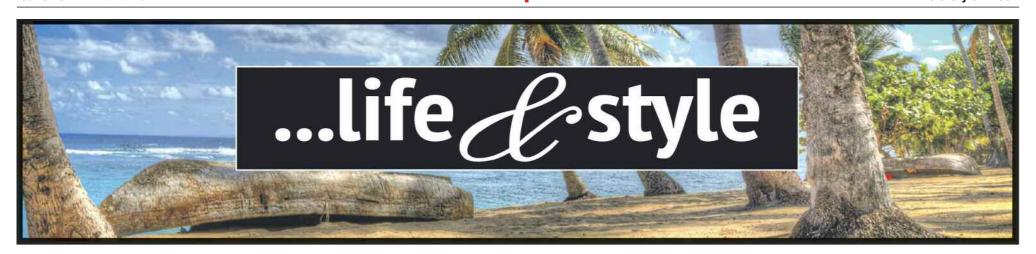

These foods will help you burn

Salmon

Salmon is a lean protein which is packed with omega-3s, meaning it is extremely beneficial for weight loss as the body must work harder to digest it.

In addition, salmon is a great source of omega-3 fatty acids which are shown to reduce inflammation and promote fat burning, with studies showing that fish oil supplementation can help to reduce weight and the stress hormone cortisol, which is also linked to fat storage.

The average British family bins one third of a ton of left-over food every year a study has revealed.

Research carried out among 2,000 adults found oversize portions from Chinese takeaways account for a large chunk of the staggering 745lbs or 338kgs of waste.

Uneaten meat and vegetables from the popular weekend meal also find their way into the bin frequently.

Parents who over-estimate family meal quantities and fussy kids who turn their nose up at dinner time also contributes to the incredible figure.

In fact, the study showed as many as six in ten families regularly fail to finish everything on their plates, so end up scraping the left-overs into the food bin.

The study found the average household will throw away 6.5 kilograms of food waste every week - a total of 338 kilograms or 745lbs a year.

And of that, almost one-fifth is made up of leftovers and cooked food that has gone uneaten - the equivalent of around three full plates of food each week.

60% of Brits admitted they don't always eat everything that is put in front of them, with another 70% saying they usually have to scrape uneaten food off their children's plates as well. When it comes to children, 41% leave something because they are too fussy to eat it.

Brits admitted they worry about the amount of food they throw away, with another 56% concerned about the cost. Despite this, 55% admit they know they often cook too much food for their family.

A spokesman for food waste disposal firm InSinkErator, which commissioned the research, said: "Throwing away the odd bit of food from each meal might not seem like a lot, but when you add that up over a week or year, it's a staggering amount.

"Not only is it horrible to see how much food gets wasted, but if you think of how much you spend buying that food in the first place, it can be quite unsettling.

"But it's interesting to see that Chinese takeaway is one of the main meals we throw away. Many people order too much and end up struggling to eat it all.

"If you or members of your family find it difficult to clear their plate and your food waste bin is bulging, cooking less will not only mean you end up saving yourself money but you won't have to deal with messy job of throwing the food waste away."

Childcare crisis means new mothers miss out on £70,000 of earnings



Women who have a baby miss out on almost £70,000 in wages over the following decade, according to a new analysis of the impact of Britain's childcare provision.

The Social Market Foundation (SMF) revealed the new figure as it launched a crossparty commission on childcare led by

Conservative and Labour MPs.

The commissioners, John Penrose MP and Siobhain McDonagh MP, will work with the SMF to analyse the impact of poor childcare provision on wages and poverty, and ways to improve provision.

The SMF revealed that a woman who had

her first child in 2010/11 typically suffered a cumulative income loss of £66,434 over the following nine years, relative to what would have happened if she had remained childless.

The income loss figure measures the money a woman would have earned if her career had progressed in the way that similar women without children earn. It does not take account of the additional spending that parents face.

The figures are based on new SMF analysis of the Understanding Society dataset, which tracks the experiences of around 30,000 people over decades.

Looking at women who were 25-35 in 2009/10, the SMF found that the typical woman who remained childless would have seen her earnings rise by around third over the next decade. By contrast, a woman who had a first child in 2010/11 was earning 10%

Women on lower incomes face the biggest losses in earnings in their child's early years, the SMF found. In the first three years after having a baby, women on lower incomes saw their earnings fall by around 30%. But women on higher wages saw their earnings drop by around 20%.

The SMF said that the high cost and limited availability of childcare means it is often not possible for parents to work as much as they want to, leading to reduced earnings, stalled wage growth, and limited career progression.

Britain has some of the most expensive childcare in the developed world. Families paying for childcare typically spend more than 7% of their income on it, the SMF has calculated. Families on the lowest wages pay the highest share of their income on childcare.

The SMF Childcare Commission will now carry out more data analysis, take evidence from key stakeholders and make recommendations later this year on how to make Britain's childcare provision work better for families and the economy.
Scott Corfe, SMF Research Director said:

"In the UK, having a child is expensive particularly for women. With childcare costs prohibitive, many either have to stop working, or work reduced hours, in order to look after children. This means derailed career paths, missed promotion opportunities, and tens of thousands of pounds of foregone earnings over the course of a decade.

"No government can claim to have solved the cost-of-living crisis – nor to be doing the most to achieve gender equality – if the costs of childcare remain unaddressed. This is a national problem that needs a national solution, and our new cross-party commission will provide some answers to deliver the highquality and affordable childcare that Britain

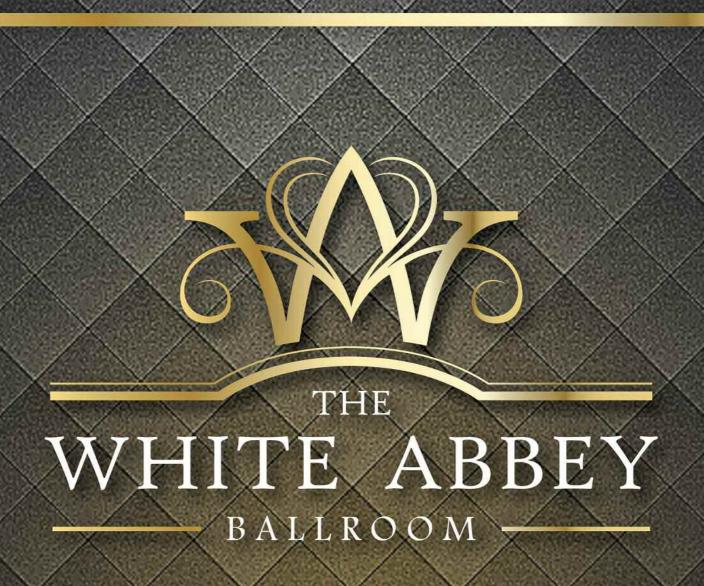

stumble upon an old bracelet that belonged to her reputedly mystical great-grandmother. The bangle has links to Kamala's Pakistani heritage and the trauma of the 1947 India/Pakistan

The series so far on Disney+ hasn't disappointed. Fans of Marvel, and even those who are not, have left positive raving Nisha K Ali as head writer for the series, as well

Pakistani Muslim. I think we were balanced

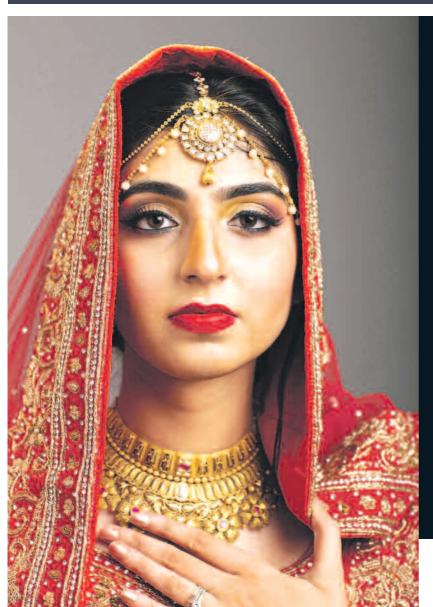

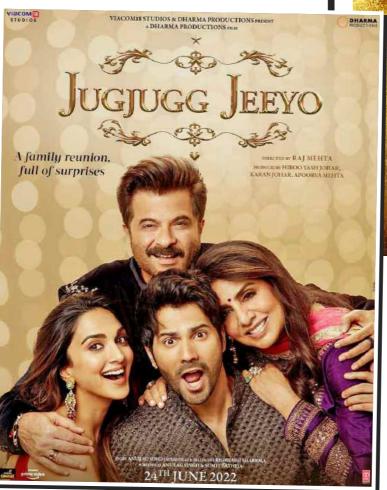
Q: Do you relate to your character?

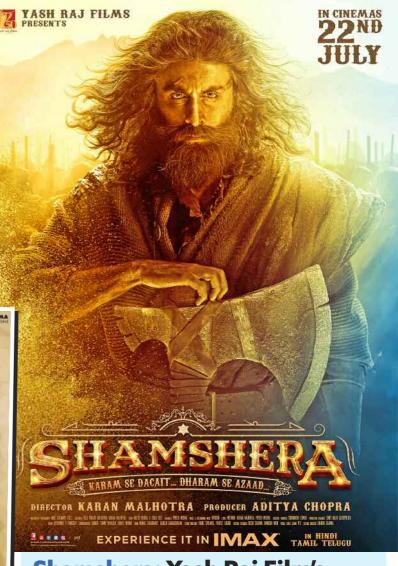

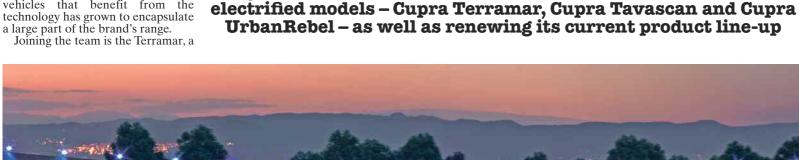

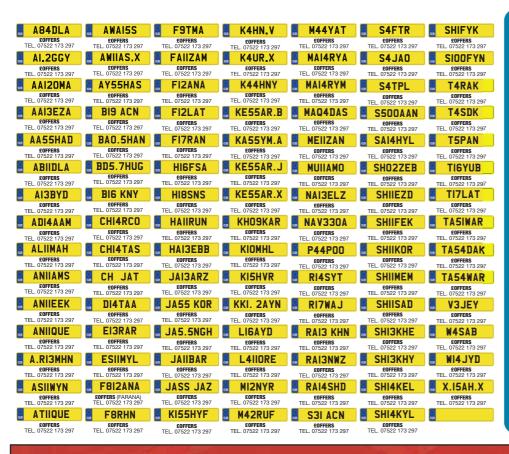

The Premier League rich list: What the top players earn from social media

New research has found how much the Premier League's top stars could be earning off the pitch through sponsored posts on Instagram.

The study by odds comparison site Odds Scanner analysed the follower counts and engagement rates of the Premier League's top players to determine how much they could each earn per sponsored post on social media.

It found that thanks to Cristiano Ronaldo's 452,045,459 followers and an engagement rate with his posts of 1.89%, he could earn on average £754,228 per sponsored post on Instagram. He is the most followed player in the Premier League by far, with

each of the posts on his account averaging over 8,000,000 likes at a time.

Another Manchester United player, Paul Pogba, was the second-highest earner through social media. With 54,187,693 Instagram followers at the time of the study and an engagement rate of 1.06%, he could be earning upwards of £114,701.43 for every sponsored post on his Instagram, where each post averages 574,328 likes. Third place goes to

Liverpool's Mohamed Salah, with the Egyptian expecting around £108,282,89 per sponsored Instagram post. This is thanks to a follower count of £1161,833 and an engagement 51,161,833 and an engagement rate of 2.88%. His account also averages over 1,000,000 likes

per post. New Villa signing Philippe Coutinho takes fourth place in the list, with an Instagram follower count of 24,761,154 and an engagement rate of 1.59%, meaning he could earn around £52,430.73 per sponsored post on the platform. Coutinho makes his first Premier League return since 2018 with Aston Villa after signing on a permanent deal in May 2022. Chelsea's Thiago Silva takes fifth place on the list, potentially carning around 541 051 64 per

earning around £41,051.64 per sponsored Instagram post. This is thanks to a follower count of 19,398,200 and an engagement rate of 19,398,200. His posts on the platform also average around 115,993 likes.

Erling Haaland, Man City's

marquee signing set to join in July, now makes his way into the list as not only one of the league's most-followed players but also one of the highest earners from social media Thanks to a follower count of 16,040,094 and an engagement rate of 4.54%, he could earn around £33,921 for every

sponsored Instagram post.
Commenting on the findings,
a spokesperson from Odds
Scanner said: "While some of the Premier League's top players are already on salaries worth millions, this list highlights how powerful social media can be as a side gig, with companies potentially willing to pay big money to have their products advertised by some of the world's host football players." world's best football players.

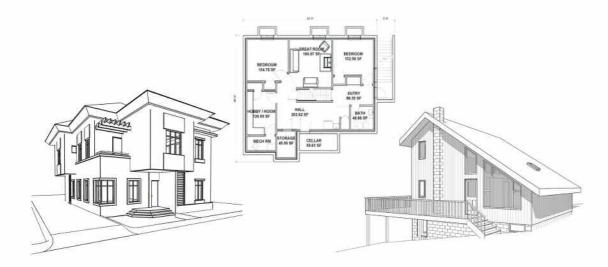

Women and men's football teams deserve equal prize money for winning the FA Cup, GMB congress was told

The union, which represent match hospitality and security staff at several premiere league stadiums, calls on Football Association to end the gender discrimination in footballers pay.

"Hard-fought equal pay battles have been won across every sector and it's long overdue in football.

"This blatant sexism is outdated and pay parity for our women's teams is overdue.

"Overall, the total prize money for the women's FA Cup is £309,000 which is shared by 300 teams.

"This compares with £15.9 million for the men's FA Cup which is shared by 735 teams.

"The FA should level up the prize money available for women's teams in the FA Cup to the level paid to the men's teams in the same competition.

"There's plenty of money in the game – so let's blow the final whistle on this shameful practise.
